Institutional Authorization

Western Governors University is authorized to provide its educational programs in Michigan through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their [website](#).

Licensure Pathway

Candidates applying for a teaching license in Michigan do so through the direct licensure pathway. Direct licensure is available when a state allows candidates to be licensed upon completion of a program that is approved in the state of Utah. Candidates apply for licensure upon WGU confirming completion of an out-of-state program. They are not required to obtain a Utah license. Educational Prerequisites

WGU's education preparation programs satisfy the applicable educational prerequisites for professional licensure in Michigan for the following initial licenses:

Note that Michigan requires a valid certificate of course completion for First Aid training, including Cardiopulmonary Resuscitation (CPR) for both children and adults. This training may be from the American Red Cross, the American Heart Association, or from a comparable organization approved by the Michigan Department of Education. WGU has not made a determination as to whether the following programs will meet the educational prerequisites for endorsements to an existing Michigan license (or a separate license in the case of MS Educational Leadership):

- *MA Science Education (Secondary Earth Science)*

Certified Michigan educators can apply for additional teaching endorsements by completing a teacher preparation endorsement program, with at least 20 semester credits, and passing the applicable Michigan Test for Teacher Certification subject matter examination. Endorsement programs completed through a teacher preparation college or university outside Michigan, like WGU, must be evaluated by the Michigan Office of Educator Excellence (Michigan recommends waiting to register for and take the corresponding MTTC exam until the evaluation has been done).

The requirements to add an endorsement in Michigan are the same, whether you are adding an endorsement at a new grade level (Elementary to Secondary) or the same grade level (Secondary to Secondary). More information regarding endorsements in Michigan is available at [this link](#).
