Institutional Authorization

Western Governors University is authorized to provide its educational programs in Puerto Rico through a state authorization reciprocity agreement (NC-SARA). More information about NC-SARA is available on their [website](#).

Licensure Pathway

Candidates applying for a teaching license in the Puerto Rico do so through the reciprocity licensure pathway. Licensing through reciprocity means that candidates must first acquire a Utah teaching license before applying for licensure in their state. Not all states require reciprocity for all programs. Educational Prerequisites

WGU's education preparation programs satisfy the educational prerequisites for professional licensure in Puerto Rico for the licenses listed below with the exception of a course required in Puerto Rico history. The Puerto Rico history course is not required to obtain the Utah license which is used in the reciprocity process.

*Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

To obtain a license as Director de Escuela in Puerto Rico, WGU students complete the Educational Leadership program for the state of Utah and apply for that license in Utah. They then apply for the Puerto Rico license using the reciprocity pathway. WGU's Educational Leadership Program meets the educational prerequisites in Utah for a license as a Principal. - *MAT Science Education (Secondary) if seeking the Earth Science license* – Puerto Rico does not have an Earth Science license.
- *Endorsement English Language Learning (PreK-12)* – Puerto Rico does not have an ELL license.
- *MA English Language Learning (PreK-12)* – Puerto Rico does not have an ELL license.
- *MAT English Education (Secondary)* – Puerto Rico does not have a Secondary English license.
