What Are Clinical Field Experiences?



A combination of direct and/or indirect hours through which professional practice and simulation experiences are supervised, verified, evaluated, and documented.

All learners in entry-level professional nursing programs will engage in direct patient care learning activities in all four spheres of care and across the life span (Wellness/ Disease Prevention, Regenerative/Restorative Care, Hospice Palliative Care and Chronic Disease Management) and provide clear evidence of student competency achievement (AACN, 2021, P 19)

Clinical Field Experience Courses

D224- Global Health & Population Restorative and Preventative Care

• In the required (35 direct care hours + 20 indirect care hours) student field experience, the student will become familiar with the many methods nurses use to interact within their communities to support and maintain the health of the population through restorative/regenerative care or wellness/disease prevention.

D225- Emerging Professional Practice Chronic Health and Palliative Care

• In the required (45 direct care hours) student field experience, the student will become familiar with the many methods nurses use to interact within their communities to support and maintain the health of the population through the management of chronic disease or palliative/hospice care.

D224/D225

Appropriate Sites

- Sites must be appropriate outpatient, community-focused sites.
 - Procedural sites are not appropriate (i.e., surgery center, endoscopy, cath lab, radiology, etc.)
 - In-patient, acute care, hospital settings are not appropriate.
 - The current area/unit where you currently work is not appropriate.
- The site must agree to engage in an affiliation agreement with WGU and accept the student.
- There must be a BSN (preferred) or higher Degree RN (MSN, NP, DNP) who provides direct patient care to facilitate the field experiences.
- You must be able to discuss and explain the experiences for one or more spheres of care appropriate for the course.
- **NOTE: Recommendations are made in the table below based on the typical spheres of care provided at such sites. It is best to discuss with your instructor or preceptor the spheres of care actually provide at the site during the direct patient care.

- Must have earned a Bachelor's degree or higher in nursing (BSN, MSN, NP, DNP)
- Must have 1 year of experience primarily in current position
- Must hold an active, unencumbered license in the state where the organization is located or hold a multistate license in another state which allows them to proactive in that state



Global and Population Health

D224 – Wellness/Disease Prevention OR Regenerative Field Experience

D224 – Wellness/Disease Prevention in a population – identify an at-risk population from the community assessment and complete direct hours such as patient assessment, education, planning related to preventing risk for this population.

D224 - Regenerative/Restorative Care - identify a current issue/disease and focus upon the restorative care needs of this population by completing direct hours such as patient assessment, education, planning, or communication with this population.

This is an **interactive** direct care patient experience – speak with patients, observe care, education, etc.

55 Total Hours

- 35 direct care precepted hours
- 20 indirect care hours from course assignments (i.e., Shadow Health and Community Assessment)

Validating Field Experience Hours - D224

Submit field experience activities through the "D224 Activity Log" link found on your Field Experience Page, by including the following:

- 1. Record a total of **55** hours that meet the following requirements:
 - a) 20 indirect care hours will auto-populate **10** hours for the population assessment, and **10** hours for shadow health assessment.
 - **b) 35** direct care precepted hours (details are provided in the attached "Field Experience Requirements")
- 2. Enter the start date and time for the day's field experience activity (Each day is logged separately).
- 3. Enter the end date and time for the day's field experience activity (Each day is logged separately)
- 4. Discuss specific details of the education, resources, services, collaboration, communication, etc. the **NURSE** provides while engaging with patients during this direct care experience that promotes the chosen sphere of care.
- 5. Select which sphere of care supported by the day's *nursing* activities: Wellness, Disease Prevention or Regenerative/Restorative Health.
- 6. **ONLY** discuss the selected Sphere of Care: Describe the rationale (why) for the nursing interventions (education, resources, services, collaboration, communication, etc.) discussed above and how these work to achieve the chosen sphere of care.
- **NOTE: The log will not be available until you have received clearance from CLPS to begin.

 Note: Orientation, Training, or Prep time is not to be included in reported hours.

APPROPRIATE D225 PRECEPTORS

- Must have earned a Bachelor's degree or higher in nursing (BSN, MSN, NP, DNP)
- Must have 1 year of experience primarily in areas of Chronic Disease Management and Palliative or Hospice Care
- Must hold an active, unencumbered license in the state where the organization is located or hold a multistate license in another state which allows them to proactive in that state



Emerging Professional Practice

D225 - Chronic Disease Management OR Palliative/ Hospice Care Field Experience

D225 - Chronic Disease Management in a population — •identify a population with chronic disease and focus on direct care hours for health maintenance such as patient assessment, education, planning related to this population.

D225 – Palliative/Hospice care in a population -identify a population with life-limiting or endof-life issues and focus upon care needs to support or maintain quality of life by completing direct care hours such as patient assessment, education, planning, or communication with this population.

This is an interactive direct patient care experience – speak with patients, observe care, education, etc.

- 3. Enter the end date and time for the day's field experience activity (Each day is logged separately)
- 4. Discuss specific details of the education, resources, services, collaboration, communication, etc. the **NURSE** provides while engaging with patients during this direct care experience that promotes the chosen sphere of care.
- 5. Select which sphere of care supported by the day's *nursing* activities: Chronic Disease Management or Palliative/Hospice Care.
- 6. **ONLY** discuss the selected Sphere of Care: Describe the rationale (why) for the nursing interventions (education, resources, services, collaboration, communication, etc.) discussed above and how these work to achieve the chosen sphere of care.
- **NOTE: The log will not be available until you have completed and passed D224.

What is My Role When on Site for my Field Experience?

- Professionally represent the Western Governors University Nursing Program.
- Determine ahead of time appropriate professional attire for the setting while completing the FE.
- When participating in FE the student is required to wear a WGU Clinical Badge
- Conduct practice without discrimination based on age, race, religion, nation of origin, sexual orientation, gender identification, or handicap.
- Respect the dignity and rights of patients and/or students regardless of social or economic status.
- Respect your BSN prepared nurse and accept supervision and guidance.
- Seek out experiences that are appropriate the field experience courses.




Progressing from Novice to Expert in the BSN Program

Cold calling provides a great opportunity to introduce yourself, discuss your need for placement, and overall goals for your degree









Order a WGU Clinical Badge within the Field Experience Page



- A WGU Clinical ID Badge provides proof of your student status and is required as part of your clinical placement.
- After you submit the completed request form, your Clinical Badge will be mailed to the address provided. You can expect to receive your Clinical Badge within 20 business days.
- Failure to order your Clinical Badge in a timely manner will delay receipt and can impact your ability to attend clinical field experience.

FERPA

Family Educational Rights & Privacy Act

The Family Educational Rights and Privacy Act of 1974 (FERPA) is a Federal law designed to protect the privacy of student education records.

Due to the FERPA laws, WGU may not give out your personal information without your written consent. Before we can begin working on your placement, which may require us to give out information to a site, we need you to fill out a Clinical FERPA information release form from your Field Experience Page.


Professional Conduct

In keeping with the College of Health Professions mission, students and graduates of WGU's health programs are expected to have the needed proficiencies and to demonstrate the professional dispositions appropriate to the field of health.

You will read and acknowledge the standards of professional conduct and submitting your acknowledgement will satisfy this required.

Knowledge Check

Within 48 hours of reviewing this Clinical Information Session, you should complete the Knowledge Check, demonstrating your understanding of the information covered in the session and your next steps toward your Field Experience



BSNU Preplacement Application

Complete the Preplacement Application 6 months prior to your first Field Experience course.



The Preplacement Application is a Student Profile where you will provide the name of your current employer, indicate if you are in health professional shortage area, and provide emergency contact information.

BSNU PREPLACEMENT APPLICATION

The completion and submission of the BSNU Preplacement Application is required to initiate the placement process for the clinical portion of your program. Please complete the form in its entirety. Incomplete applications will impact your ability to start the clinical placement process. Applications for placement consideration must be received at least 6 months prior to your first Clinical Internship. Late applications may cause a delay in your degree progression.

Preceptor Criteria



- Appropriate preceptors will provide direct clinical experiences appropriate to the course to include:
 - Wellness/ Disease Prevention, Regenerative/Restorative Care, Hospice Palliative Care and Chronic Disease Management
- Has an active unencumbered RN license
- Must have a BSN or higher (MSN, NP, DNP)
- Has a minimum of 1 year experience in the field experience clinical area
- Serves as a liaison/guide between the student, the clinical site/collaborative agencies
- Has agreed to support a student's learning to include:
 - ✓ providing feedback on student participation in a supportive and constructive way.
 - ✓ communicate with the course instructor at the beginning, middle and end of the field experience
- Collaborates with the student and Course Instructor to recommend additional learning experiences consistent with the learning goals and course competencies
- Approves the student's time log to verify the accrued hours
- A nursing preceptor or an interdisciplinary preceptor shall not precept more than two students at any one time.

Preceptors cannot be a member of your immediate family, cannot be your direct supervisor, or have a financial, business, or professional relationship in conflict with the duties of preceptorship.

Preceptor Identification

How do I find a preceptor?

- First, familiarize yourself with the role of the preceptor on the <u>BSNU Clinical Preceptor Page</u>
 - Know what you are asking your preceptor to do.
 - When will you need them?
 - How many hours will be involved?
 - What kind of learning opportunities are needed?
 - What credentials does the preceptor need to have?
- Start networking to identify sites and preceptors aligned with your courses
 Preceptors cannot be a member of your immediate family, cannot be your direct supervisor, or have a financial, business, or professional relationship in conflict with the duties of preceptorship.
- Google appropriate clinical sites in your area and visit them in person.
- Make the request in person. Preceptors are more likely to agree to precept if you ask them in person vs. sending an email.
- Only one RN to BSN prepared nurse preceptor can be used per course.



Preceptor Connection



The WGU BSN Student identifies a nursing preceptor (only one preceptor per course) who can precept the student in a clinical site to support the field experiences areas appropriate for the course.

- As this is a volunteer (unpaid) positions, we do not have a list of preceptors for students to choose from.
- Working with a self-identified preceptor ensures that you have a preceptor who is personally invested in your academic success.
- Working with a self-identified preceptor ensures that the preceptor will be available at a time and geographic location most suitable to your needs.

Please note: All hours are to be completed outside of regular work hours. Anything related to your current work position (e.g., CPR training, work shifts, training orientation, or courses, classes, or conferences) are not acceptable for this project, nor are drive time, orientation, or other logistical or administrative tasks (e.g., obtaining a facility badge).

Affiliation Agreements

What should I know about Clinical Sites and Affiliation Agreements?

NOTE: This is a legal contract negotiation process and can take up to 6 months to fully execute. Plan accordingly to avoid delaying your degree progression.

The WGU Contract Outreach Team will work with the Clinical Site Contract Administrator to negotiate an Affiliation Agreement. The negotiation of these agreements take time as they go back and forth several times before they are signed by both WGU and the Clinical Site.



Fully Executed Affiliation Agreement

Once the agreement is complete, the WGU Contract Outreach Team will notify the Placement Coordinator if there are any additional site-specific requirements or onboarding.

- The email is sent to the Student and Program Mentor.
- You will receive separate Clearance Confirmation Emails for D224 Global and Population Health and D225 Emerging Professional Practice.
