

## Tennessee State Loan Repayment Program (TSLRP)

TSLRP provides educational loan repayment to qualified primary care practitioners in exchange for an initial 2-year service obligation to practice full-time or part-time at an ambulatory public, non-profit or private non-profit primary care site located in a federally designated Health Professional Shortage Area (HPSA).

### Eligible Practitioners

Primary care physicians, dentists, advanced practice nurses, registered nurses, certified nurse midwives, and physician assistants, primary care behavioral and mental health psychiatrists, psychiatric nurse specialists, licensed clinical social workers, health service psychologists, marriage and family therapists, licensed professional counselors, and pharmacists.

#### Pharmacist (Pharm-D)

(*Pharmacist who only dispense medications and/or are located in retail settings are not eligible for TSLRP*)

**Eligible pharmacist should participate in an integrated health care approach which can include but is not limited to:**

Provide direct patient education and consultation

Participate in a multidisciplinary team and provide consultation or pharmacological information to other health care professionals

Provide primary care services to include vaccinations, blood pressure or CLIA waived rapid testing

(*Direct patient care can be administered via several modalities including face-to-face interaction as well as telehealth*)

### Practitioner Eligibility Requirements

Primary care providers applying for participation must meet the following TSLRP program requirements.

- Must be a United States citizen
- Must be licensed to practice in Tennessee
- Must agree to use the Tennessee State Loan Repayment Program funds only to repay qualifying educational loans

- Must have no obligation for health professional services and have not breached a health professional contract
- Agree to pay damages for breach of service
- Must not have a judgment lien against his/her property for a debt to the United States, have any federal debt written off as non-collectible, or any federal service or payment obligation waived
- Must be willing to commit to a service agreement contract for a minimum of two (2) years
- Must provide services in a health professional shortage area
- Must provide services to Medicaid and Medicare patients
- Must enter into an appropriate agreement with the State Children's Health Insurance Program (Tennessee CoverKids) to provide service to children under Title XXI
- Must provide a sliding fee scale for the uninsured which must be posted in a public area
- Must work forty (40) hours a week with no more than eight (8) hours per week spent on practice-related administrative duties or part-time, twenty (20) to thirty-nine (39) hours per week choosing a two (2) or four (4) year service obligation commitment
- Must not have any active Primary Care Loans

## Eligible Practice Site

An eligible site is an ambulatory **primary care public, non-profit or private not-for-profit** entity located in a federally designated Health Professional Shortage Area (HPSA) or a facility designated as a Federally Qualified Health Center (FQHC) or Rural Health Clinic (RHC).

*A Health Professional Shortage Area (HPSA) is a geographical area, population group, public or nonprofit private medical facility, or public facility determined by the United States Secretary of Health and Human Services to have a shortage of primary health care or dental health professionals. ## Award Amount

Maximum TSLRP award is **up to** \$50,000 for an initial 2-year service obligation contingent upon funding availability.

## Award Renewal Extension

TSLRP recipients in good standing are eligible to reapply for a maximum of **up to** \$20,000 per year in continued loan repayment awards after fulfilling their initial 2-year service obligation and as long as they have outstanding educational loans to repay contingent upon funding availability.

## Applications

The online application process is powered by REDCap. Applications are only accepted while the application cycle is open at the following link: <https://www.tn.gov/health/health-program-areas/division-of-health-disparities-elimination-/rural-health/tslrp.html>. TSLRP awards are approved until all funds are committed.

**\*\*\*Note: Only qualifying Public Non-Profit or Not-for-Profit Private ambulatory primary care entities, located in a federally designated Health Professional Shortage Area (HPSA) are eligible practice sites for participation in TSLRP. \*\*\***

## Application Process

**Applications will be reviewed for consideration with priority given to:**

- practice sites that **do not** currently have a TSLRP recipient practicing at their location  
*TSLRP awards are limited to only one provider per site and three per healthcare system per year. Consideration will be given to approving additional providers contingent upon the (a) severity of the local primary care workforce shortage (b) funding availability (c) number of TSLRP recipients currently practicing on location*
- critical need to recruit and retain primary care providers
- collaboration with local systems of care
- public health indicators
- number and spatial distribution of providers in the local area
- availability of funding during the application cycle
- length of practitioner service commitment beyond the initial 2-year obligation
