CALIFORNIA

Institutional Authorization

The California Bureau for Private Postsecondary Education does not regulate out-of-state private nonprofit institutions. Therefore, Bureau approval for WGU to offer distance education programs to students located in California is not required.

Licensure Pathway

Candidates applying for a teaching license in California will use one of three licensure pathways (reciprocity, approved, or direct) depending on their program. Information on the different licensure pathways is available in the <u>licensure handbook</u>. Information on which pathway a certain program utilizes and complete details on licensure requirements in the state of California can also be found in the <u>licensure handbook</u>.

^{*}Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure. Applicants will receive a credential based on the initial license already held (preliminary, clear, etc.).

California requires the completion of a course (at least two semester units or three quarter units) in the provisions and principles of the U.S. Constitution or the passing of an exam. Information on this requirement (applicable to some programs) is available in the <u>licensure handbook</u>.

Licenses obtained through the approved pathway include the English Learner Authorization (ELAM or ELAS). The ELAM/ELAS authorizes the holder to teach English Language Development (ELD) in an integrated and/or designated classroom in alignment with the attached multiple or single subject credential.



Approved pathway candidates must complete CPR certification training for licensure. The CPR certification must include adult, child, and infant CPR aid and must meet either American Heart Association (AHA) or American Red Cross (ARC) standards. Certification does not need to meet OSHA standards.
