# **GUAM**

#### **Institutional Authorization**

The Guam Council on Post-Secondary Institution Certification does not regulate distance education. Therefore, approval for WGU to offer distance education programs to students located in Guam is not required.

#### **Licensure Pathway**

Candidates applying for a teaching license in Guam do so through the direct licensure pathway. Information on the different licensure pathways is available in the <u>licensure handbook</u>. Complete details on licensure requirements in Guam as well as information on applying using the direct licensure pathway can also be found in the <u>licensure handbook</u>.

\*Advanced programs are for already licensed teachers who want to add an additional teaching area or field to their licenses (or a separate license for Educational Leadership). These programs are not intended for aspiring teachers seeking initial licensure.

<sup>^</sup>Guam requires five years of full time classroom teaching experience for Educational Leadership candidates.

Note that after a candidate receives initial certification, candidates for licensure in Guam need to complete a three-semester credit course in Guam history and culture during the first year of certification. This course is not available through WGU.

To add an endorsement to a Guam teaching license at a new grade level, candidates must complete student teaching in the new area. Therefore, candidates should not enroll in an additional advanced program at WGU if they do not already hold a secondary teaching license.
